\$100,000 to \$999,999 for commodities and general services, and sole sources.	January 19, 2018
\$100,000 to \$999,999 for professional and artistic services	January 19, 2018
\$50,000 to \$100,000 for commodities and general services	February 1, 2018
\$50,000 to \$100,000 for professional and artistic services	February 1, 2018
Between \$5,500 and up to \$49,999	April 1, 2018
Up to \$100,000 for construction and construction-related services	April 1, 2018
